

## INSTRUCTIONS - VAX DOCUMENTS

The following are simple directions to follow in order to retain all one's entitlements intact without having to undergo any vaccinations.

1. Entitlements are unencumbered, unconditional and were created for the benefit of the beneficiary – YOU, the living soul. CLAIM them!
2. No one and no legislation or statute, act or code can compel you to accept vaccination in order to retain your benefits without your consent, neither can they over-ride or over-rule CONTRACT LAW as it prevails.
3. The process is mandatory because without noticing the Ministers of your NON-consent and your objection to vaccination, it will be PRESUMED by your silence that you have assented to being vaccinated. Your silence is regarded as your consent. NEVER EVER remain silent on any issue you object to, and don't consent to. You must EXPRESS your non-consent by way of Notice, or better, a 'My Will Notice'.

The key documents you need are;

VAX1 - My Will Notice – directed to each of 5 key Ministers individually and sent to each of them. So exchange their name & addresses accordingly at the top, and also their name down the bottom of letter.

VAX2 - My Will Notice and Mandate – only directed to the Prime Minister, but copied and sent to all 5 ministers, and

VAX3 - Affidavit of Claimant directed to each of 5 key Ministers individually and sent to each of them.

VAX4 – 'Restore Entitlements' only directed to and sent to Anne Ruston (if relevant).

Both 'My Will Notice' (VAX1) and 'My Will Notice & Mandate' (VAX2) MUST be signed by the party (you) claiming their entitlements without being vaccinated.

The 'Affidavit of Claimant' (VAX3) is directed to all 5 Ministers for their signing and sealing before a JP. Its purpose is to ensure the Ministers either a) accept liability for the devastating effect of vaccinations on your health BEFORE you attain any vaccination OR b) direct to you in writing that you are exempt whilst retaining your entitlements, and to take their letter to the offices of Social Security so they can be informed of your entitlements while retaining your right to elect not to be vaccinated.

NB. FOR ALL DOCUMENTS: PLEASE READ AND EDIT TO MAKE SURE ALL IS RELEVANT TO YOU! For example, replace 'We' with 'I' if sent as a legally married couple, or 'I' sent as an individual; so make sure you change throughout all documents accordingly.

When signing letters follow this format:

By:

Signature (in blue pen)

First Name, Surname (No Mr. or Mrs.)

Send all relevant documents TOGETHER in the same **REGISTERED MAIL** envelope to EACH of the 5 MP's.

PLUS, IF YOU HAVEN'T ALREADY – SEND THE 'CONSCIENTIOUS OBJECTION FORM' TO DEPT OF HUMAN

SERVICES – address is on the form itself. Since this form no longer exists you copy it and make your own without the medicare logo or barcode. Be creative its your agreement that you want them to accept.

**NEXT STEPS:** IF **NO RESPONSE** FROM 'MY WILL NOTICE' (VAX1) AFTER 21 DAYS (DIARISE DATES FROM YOUR FIRST LETTERS) – REFER TO VAX5 - 'DEFAULT NOTICE' AND THEN THE VAX6 - 'FINAL NOTICE' IF STILL NO RESPONSE AFTER ANOTHER 21 DAYS.
